COMMISSION UPDATE COURSE - Requirement for all active licensees (4 Hours)

Course Objective: To protect the public through requiring all real estate licensees to complete 4 hours of continuing education covering new laws, Commission rules, recent court decisions, changing standards of practice and other areas of concern to the public, Commission and Industry. (Must take a 4-hour class each year during your 3-year renewal cycle)

To receive continuing education credit, students must attend the full course. Any student arriving 10 minutes after the class has started may stay for the class, but will not receive CE credit. Students must achieve a 70% or better on any required tests to receive credit. If student fails, they will receive notice with the requirements and the instruction on how to retake the exam. This class requires pre-registration and full payment by registration deadline, which is 3 days before the class.

Refunds: If the course is cancelled, or the student withdraws 7 days before the course, a full refund will be issued. A 50% refund for any cancellation made up to two business days before the date of the class. No refund will be issued to any student who does not cancel two business days before the date of the class or fails to appear for a class. Any refund due to the student will be issued within 30 days of cancellation.
