NAR ETHICS - (4 HOURS-CE). This course provides a basic review of the REALTOR Code of Ethics. You will be presented with relevant data to develop an awareness of the new broker relationships and the ethical considerations each presents. This course satisfies the NAR mandatory requirement for membership renewal

The Loveland-Berthoud Association of REALTORS® requires its members to take the class every three years coinciding with their license renewal. LBAR sends letters to its members reminding them of this requirement.

Non-Realtor Member fee: \$50.00

To receive continuing education credit, students must be in attendance from the beginning to end of the class. Any student arriving 15 minutes after the class has started may stay for the class, but will not receive CE credit. This class requires pre-registration and full payment by registration deadline. Registration deadline is 3 days prior to each class.

Refunds: If the course is cancelled, or the student withdraws at least 7 days prior to the course, a full refund will be issued. Cancellation within 5 days of the course will result in a refund of the tuition less a 25% cancellation charge. If the student fails to appear for a class or fails to cancel, no refund will be issued. Any refund due to the student will be issued within 30 days of cancellation, subject to receipt of a written request.
